General Rules of the Room:

User is defined as the person who booked the Community Room.

- 1. The user is responsible for keeping order and for the proper conduct of those in attendance. Children and teenagers must be accompanied by an adult sponsor who is present in the room for the entire meeting.
- 2. The user must abide by the posted occupancy limit (42).
- 3. Food/Beverages (non-alcoholic) are allowed in the room. The community room contains a kitchenette with accommodations (i.e., sink, microwave, keurig) that are available for use. Users should bring their own supplies (e.g., napkins, plastic dinnerware); however, some items are available in the cabinets if needed.
- 4. The premises must be left secure, clean, and in good order. In the event of a spill/stain that couldn't be cleaned using the supplies on hand, please report to one of the contacts below so that we may take care of it in a timely manner.
- 5. Please refrain from affixing items to the walls and/or ceiling with any form of tape, tack, or nail. Do not move or alter any art work on display.
- 6. No solicitation is allowed in the Community Room. This means no selling of products, businesses or services, no charging for attendance, and absolutely no multi-level marketing.
- 7. Please leave the room exactly as you found it when you arrived. We appreciate you helping us keep our Community Room nice for everyone to enjoy. Thank you!

Safety/Security:

- 1. This is a smoke-free location. Please no smoking in/near the building.
- 2. Serving and/or consuming alcoholic beverages is not allowed.
- 3. Use of candles and any type of pyrotechnics and/or smoke generators is strictly prohibited.

- 4. Primary entry/exit and use of the Community Room should be through the side door (i.e., drive-up lane side). The door on the "map wall" may be used for exit in the event of an emergency; however, this door provides no means for re-entry.
- 5. Avidia Bank is not responsible for theft or damage to personal property brought into the Community Room facility.
